## BOMBAY MOTOR VEHICLES TAX ACT, 1958

## READ CAREFULLY THE FOLLOWING INSTRUCTIONS

1. No vehicle can be used on any road unless the tax leviable has been paid. In default of payment, the vehicle is liable to be seized and the owner liable to be prosecuted.
2. In cases where the annual rate of tax is Rs. 200 or less, the tax must be paid for a minimum period of two quarters. Where the annual rate of tax is more than Rs. 200, the tax can be paid for a quarter or multiple of quarters of a year.
3. The commencement of the year and the four quarters is indicated on page 1.
4. The annual and quarterly rates of tax are shown on page 7.
5. When tax is due, the amount of tax accompanied by this Certificate of Taxation valid certificate of insurance and application in form 'AT' duly filled in should be paid only to the Taxation Authority within whose area the tax payer resides or has his place of business within 10 days in the case of non-transport vehicles, and 20 days in the case of transport vehicles and breakdown vehicles, of the expiry of the period for which tax was last paid.
6. When there is any change in the place of residence or place of business as recorded in the Certificate of Taxation of the vehicle, intimation of the new address should be given to the Taxation Authority within 30 days of the change, and the new address got endorsed in the said certificate. If the new address falls within the jurisdiction of another Taxation Authority in this State, the change in the address should be got endorsed from that authority and intimation should also be given to the authority having jurisdiction over the previous place. Failure to do so in time, may create difficulties being caused in accepting payment of tax, and may render the defaulter liable for prosecution.

7. This Certificate of Taxation should always be available on the vehicle for inspection on demand by Officers of Police and Motor Vehicles Department.

8. If the original Certificate of Taxation is lost, destroyed, altered or has become illegible, the fact should be immediately reported to the Taxation Authority and a duplicate obtained and carried on the vehicle. If the one which was reported lost is found subsequently, it should be surrendered immediately to the Taxation Authority concerned.

9. If for any reason the motor vehicle is not intended to be used, intimation of non-use should be given for the declaration in writing along with this Certificate to the appropriate Taxation Authority, before the commencement of non-use (Please see foot-note)

10. If a motor vehicle is permanently removed to other State or Region or its registration is cancelled or it is destroyed immediate intimation should be given to the Taxation Authority.

11. If at any time any alteration or change is made in the motor vehicle or in its use or in its area of operation (in respect of transport vehicles), so as to change the taxation class, intimation of the same should be given to the appropriate Taxation Authority. Whereas a result of such a change tax at higher rate becomes leviable, the difference of tax due should be paid along with the declaration in form 'BT' and this Certificate of Taxation, within 14 days of making of such alteration or before change in its use or the area of operation, as the case may be.

*Note.*—For particulars to be mentioned in the intimation of non-use, see rule 5(1) of the Bombay Motor Vehicles Tax Rules, 1959.

### READ CAREFULLY THE FOLLOWING INSTRUCTIONS

1. Keep this certificate carefully. If it refers to a transport vehicle, it must be kept in the vehicle and be produced on demand by a Motor Vehicles Inspector or any officer in charge of a police station at any time. If it refers to any other vehicle, you will have to produce it within 15 days of its being demanded. If, therefore, you lose the certificate, you will become liable for prosecution under section 130 of the Act and will also have trouble and delay in payment of the tax and obtaining a tax token or in disposing off the vehicle. You should, therefore, immediately report the loss or destruction of the certificate, in form 26 which may be obtained from the office of any Registering Authority. The report should be made to the Registering Authority with whom the vehicle is registered.

2. If the particulars on Pages 1 to 7 are not correct, you should at once take, or send, the certificate to the Registering or the Taxation Authority, as the case may be, and point out the mistakes.

#### Alteration of vehicle

3. You should not make any change in the Vehicle which affects the particulars contained in the Certificate of Registration (especially items 1 to 18 on Pages 4 to 6) unless you have given notice, to the Registering Authority within whose jurisdiction you reside, of the alterations you propose to make and have obtained the approval of that Registering Authority to make such alterations [Section 52(1) of M. V. Act, 1988].

#### Change of address

4. If you change your address you must within thirty days intimate the new address to the Registering Authority having jurisdiction on such new address and forward the Certificate of registration to that

authority, so that new address may be entered therein. This will not apply if the change is of a temporary nature not exceeding six months.

#### Change of ownership

5. When you transfer the vehicle to another person you should within fourteen days—

- (a) Report the transfer in the prescribed form 29 to the Registering Authority within whose jurisdiction the transfer is effected, and
- (b) Hand over the certificate of registration and one copy of form 29 to the person to whom you have transferred the vehicle.
- (c) In case the vehicle is the subject of an agreement of hire-purchase and such an agreement has been fulfilled get the hire-purchase agreement cancelled by applying in the prescribed form 35.
- (d) If the agreement is to be continued in relation to the transfer, get the consent of the party to the H. P. agreement on prescribed form included in form 30.

#### Transfer to another State

6. When a vehicle is transferred to you by another person you must within thirty days apply to the Registering Authority within whose jurisdiction you reside or have place of business in the prescribed form 30 and forward certificate of registration, copy of form 29 given by previous owner, Certificate of insurance valid in your name from the date of purchase to that authority (section 50 of M. V. Act, 1988).

7. If the registered owner of the vehicle covered by the certificate no longer resides in the State in which the vehicle is re-registered, he is bound to report the matter to the Registering Authority, nearest to his

place of residence or business and after residing in the new State for 12 months he may be required to obtain and affix to the Vehicle a new registration mark (Number plate).

#### Validity of the Certificate

8. The Certificate of Registration is valid throughout the State of India, but does not entitle the holder to use the Vehicle anywhere without payment of the tax due under the provision of any legislation in force.

9. If the vehicle to which the Certificate refers is a transport vehicle that is to say, is used for the Carriage of goods, or is a locomotive or a tractor or is used for the Carriage of Passengers for hire or reward a permit is required under the provisions of Section 66 of the Act and the Certificate of registration is only effective so long as there is in force a certificate of fitness issued under Section 56.

#### Cessation of validity of the Certificate

10. If the vehicle described in the Certificate is destroyed or becomes permanently unfit for use, or is permanently removed out of India, the registered owner should return the Certificate of registration to the authority with whom the vehicle was registered. This should be done within 14 days. Failure to do so renders the owner liable to prosecution.

#### Special warning to drivers of transport vehicles

11. If you load the Vehicle or drive it when it is loaded in such a way that the laden weight or the axle weight of any axle, or the number of passengers being carried exceeds the laden weight, the axle weight or the number of passengers specified on Pages 4 to 6 of this book, you will be liable, upon conviction under section 194 of the Act, to fine which may extend to Rs. 2,000 in the case of the first offence and to Rs. 5,000 in the case of a second or subsequent offence.
